### **Budget Report:** (Scott, Kitty)

- Budget Modifications Approved
- No refund for two day shipping
- Timeline for reimbursement and process still hold many gaps with payment to vendors and delivery of checks in a timely manner. CHA provides a contractual agreement to the state on services. Many communications needed regarding reimbursement through MRC funds. Again addressing the need for a smoother process through CHA.
- Need status on the purchase shelter supplies (blankets, comfort kits, tarps, extension cords and power strips) and Stop the Bleed presentation supplies (4 CAT tourniquets and 2 training arms), CPR Instructor payment and NACCHO reimbursement.
- Order additional trauma packs for upcoming Stop the Bleed Trainings.
